Fire in Delhi nail polish factory, 9 labourers injured

TSN/New Delhi A least nine labourers suffered burn injuries when a sive fire broke out in a nail polish manufacturing factory in the early hours of Friday, a fire officer said.

"Around 2.48 am, the Delhi Fire Service control room received information about a fire in a nail polish factory at West Delhi's Bawana Industrial area. Fifteen fire tenders were rushed to the spot to douse the fire, which started from a chemical container," the officer said.

The fire was doused by 3 am but during the rescue operation, nine labourers were found injured for the spot. The victims were riffed as Bablu (20), Chhota (21), Ram Singh (21), Kanhaiya (21), Jaggi (22), Pappu
