anata Party (BJP) has registered its win in all the ten Lok Sabha seats in Haryana. JJP candidate Sanjay Bhatia from Karnal won with the maximum number of votes 56,142, whereas Arvind Kumar Sharma from Rohtak won with the least number of votes 7,503.

Joint Chief Electoral Officer, Dr Inder Jeet said that from Ambala Lok Sabha constituency, Rattan Lal Kataria won 7,46,508 votes and defeated the Congress candidate, Kumari Selja with 3,42,345 votes. Kumari Selja received 4,04,163 votes. From Bhiwani-Mahendragarh Lok Sabha constituency, Dharambir won 7,36,699 votes and defeated the Congress candidate, Shruti Choudhary with a margin of 4,44,433. Shruti Choudhary got 2,92,236 votes.

He said that from Faridabad Lok Sabha constituency, Krishan Pal received 9,13,222 votes, whereas Congress candidate Avtar Singh Bhadana got 2,74,983 votes. Krishan Pal defeated his opponent with 6,38,239 votes. From

that from Ambala Lok Sabha constituency, Rattan Lal Kataria won 7,46,508 votes and defeated the Congress candidate, Kumari Selja with 3,42,345 votes.

Gurugram Lok Sabha constituency, BJP candidate, Rao Inderjit Singh defeated his rival Congress candidate Capt. Ajay Singh with a margin of 3,86,256 votes. Rao Inderjit Singh got 8,81,546 votes and Capt. Ajay Singh received 4,95,290 votes.

He said that from Hisar Lok Sabha constituency, Brijendra Singh got 6,03,289 votes and defeated his opponent JJP candidate, Dushyant Chautala with a margin of 3,14,068 votes. Dushyant Chautala received 2,89,221 votes. In Karnal Lok Sabha constituency, San-

Kuldeep Sharma received 2,55,452 votes.

He said that from Kurukshetra Lok Sabha constituency, Nayab Singh Saini won 6,88,629 votes and defeated Congress candidate Nirmal Singh with a margin of 3,84,591 votes. Nirmal Singh got 3,04,038 votes. In Rohtak Lok Sabha constituency, Arvind Kumar Sharma won 5,73,845 votes and defeated Congress candidate Deepender Singh Hooda with a margin of 7,503 votes. Deepender Singh Hooda received 5,66,342 votes.

In Sirsa Lok Sabha constituency, Sunita Duggal defeated her rival Congress candidate Ashok Tanwar with a margin of 3,09,918 votes. Sunita Duggal got 7,14,351 votes and Ashok Tanwar received 4,04,433 votes. In Sonapat Lok Sabha constituency, Ramesh Kaushik won 5,87,664 votes and defeated Congress candidate Bhupinder Singh Hooda with a margin of 1,64,864 votes. Bhupinder Singh Hooda received 4,22,800 votes.

Haryana Joint Chief Electoral Officer, Dr Inder Jeet said that except for the winning candidates and the candidates who were on second position, in the 17th Lok Sabha elections, the remaining 203 candidates have lost their security deposits. In Haryana, a total of 223 candidates were in fray to contest for 10 Lok Sabha seats in Lok Sabha General Elections-2019.

He said that under section 158 sub-section (4) of The Representation of the People Act, 1951, it is mandatory for the candidates to get one-sixth of the total valid votes to remain safe from losing their security deposit.

He said that 16 candidates in Ambala Lok Sabha Constituency, 19 in Bhiwani-Mahendragarh, 22 in Gurugram, 14 in Karnal, 18 in Sirsa, 27 in Sonapat, 22 in Kurukshetra, 25 in Faridabad, 24 in Hisar and 16 in Rohtak have lost their security deposits.

He said that BJP has received the highest voting percentage of 58.02 in Haryana. Apart from this, Aam Aadmi Party got 0.36 per cent, BSP 3.64 per cent, CPI 0.06 per cent, CPM 0.07 per cent, Indian National Congress 28.42 per cent, INLD 1.8 per cent and others got 7.15 per cent.

Large margin votes double



According to the EC, 20 of the NOTA votes in Gautam Buddha Nagar were made through postal ballots.

The Gautam Buddha Nagar Lok Sabha seat comprises five assembly segments of Noida, Dadri, Jewar, Khurja and Sikandrabad, with a total electorate of 22.97 lakh.

Of the 8,371 NOTA votes, Noida polled the maximum of 3,315, followed by Dadri 1,724, Khurja 1,236, Jewar 1,067 and Sikandrabad 1,009, according to the district election office.

Out of 11 women candidates in Haryana, only 1 manages to win

Chandigarh

Of the 11 women candidates in fray for the Lok Sabha polls in Haryana, only BJP's Sunita Duggal could taste victory.

Bureaucrat-turned-politician Duggal defeated state Congress chief Ashok Tanwar from the Sirsa (reserved) constituency.

Other women candidates like Kumari Selja (Ambala) and Shruti Choudhary (Bhiwani-Mahendragarh) of the Congress, JJP's Swati Yadav (Bhiwani-Mahendragarh) and Raj Bala Saini (Sonapat) of the Loktantra Suraksha Party could not manage to win.

In 53 years of its existence, Haryana has elected only five women parliamentarians.

In the 2014 Lok Sabha election, not even a single woman candidate could

manage to win in the state, which is known for its skewed gender ratio.

Chandravati, a former Janta Party leader, became the first ever woman MP from the state in 1977.

Selja, a Rajya Sabha MP, is the only woman to have been elected to the Lok Sabha thrice — twice from Ambala and once from Sirsa.

Shruti Chaudhary, grand daughter of former chief minister Chaudhary Bansi Lal, was earlier elected as an MP from Bhiwani-Mahendragarh constituency in the 2009 Lok Sabha election.

In 1999, the state sent two women MPs to the Lok Sabha — BJP's Sudha Yadav from Bhiwani-Mahendragarh and Kailash Saini of the Indian National Lok Dal (INLD) from Kurukshetra.
